Town of Felton Town Council Meeting November 9, 2015 7:00 pm

Mayor Kelley called the Town Council Meeting of Felton to order at 7:00 pm on Monday, November 9, 2015. Present at the meeting were:

<u>Council Members</u>: Mayor Dave Kelley, Vice-Mayor Joe Yapsuga, Joanne Clendaniel, Anthony Carroll and Micheal Routh (arrived late and attended Executive Session).

<u>Staff</u>: Town Manager, Rebecca Greene; Town Clerk, Amy Thomas and Sergeant, Chris Swan.

<u>Public</u>: No public were present.

Citizens Concerns:

Vice-Mayor Yapsuga stated that he received some complaints about Halloween from his neighbors that kids were demanding candy, some were not dressed in costumes and one kid asked if they could use someone's bathroom. Rebecca stated that one of those residents called Town Hall on Monday and she told her that if they ever feel uncomfortable they should call 911 while the situation is occurring.

Police Report:

Rebecca stated Chief Brown is out of Town until next month and that is why there are no ticket numbers on the report. He will present them at the next meeting. Councilwoman Clendaniel asked how the hiring of the part time officer is coming along and Sergeant Swan replied they are still reviewing applications.

Budget Report:

Vice-Mayor Yapsuga asked what the transportation funds for \$28,000 showing on the summary page of the budget. Rebecca replied that amount has been paid out of our pocket for the repaying project but we will be reimbursed from the State.

Motion: Vice-Mayor Yapsuga made a motion to accept the October 2015 budget report. Councilwoman Clendaniel seconded the motion. The motion was passed unanimously.
