

**Town of Felton  
Town Council Meeting  
July 11, 2016  
7:00 pm**

Mayor Kelley called the Town Council Meeting of Felton to order at 7:00 pm on Monday, July 11, 2016. Present at the meeting were:

**Council Members:** Mayor Dave Kelley, Vice Mayor Joe Yapsuga, Joanne Clendaniel, Anthony Carroll & Diana Dolan-Beulah.

**Staff:** Town Manager, Rebecca Greene; Chief, Levi Brown and Town Clerk, Amy Thomas.

**Public:** There was no public present.

**Citizens Concerns:**

**Police Report:**

Chief Brown presented the June 2016 police report. Mayor Kelley asked who is working all the SEU hours and Chief Brown replied Officer Guild, Officer Thomas and himself. Mayor Kelley asked what the other line is for and why it is so high and Chief replied anything that isn't patrol or criminal investigation hours. Chief Brown also stated that he accidentally added 103 hours of SEU to the other line so that will adjust the other hours from 212 to 109 hours.
