

**Town of Felton  
Town Council Meeting  
July 9, 2018  
6:30 pm**

Vice - Mayor Yapsuga called the Town Council Meeting of Felton to order at 6:30 pm on Monday, July 9, 2018. Present at the meeting were:

**Council Members:** Vice Mayor Joe Yapsuga, Joanne Clendaniel, Anthony Carroll and Diana Dolan-Beulah.

**Staff:** Chief Brown and Town Clerk Amy Thomas.

**Public:** Resident - Rebecca Chambers.

**Citizens Concerns:**

There were no Citizens Concerns.

**Motions:** Councilmember Carroll made a motion to add Abatement for 31 Kerry Circle to the Agenda. Councilmember Dolan-Beulah seconded the motion. The motion was passed unanimously.

**Abatement for 31 Kerry Circle:**

Rebecca Chambers stated that she realized she had a water leak at the house. She called Ralph but he was not in Town and Ralph sent Josh to go to her house and turn the water off. Her son fixed the leak and the water was turned back on. She is requesting an abatement of \$32.98.

**Motion:** Councilmember Clendaniel made a motion to abate \$32.98 for 31 Kerry Circle due to a water leak. Councilwoman Dolan-Beulah seconded the motion. The motion was passed unanimously. Roll Call: Vice-Mayor Yapsuga – Yes; Councilwoman Clendaniel – Yes; Councilmember Carroll – Yes; Councilwoman Dolan-Beulah – Yes. The motion was passed unanimously.

**Police Report:**

Chief Brown presented the Police Report for June 2018 asking if there were any questions. Vice-Mayor asked how Officer Boesenberg was doing on his own and Chief Brown stated that he is doing very well and fits right in with the other Employees.

Councilmember Carroll asked if we were getting another part time officer and Chief Brown stated no, but depending on our budget he would like to hire another full time officer. When an officer is on vacation the other officers schedules are being shifted and if an officer went out sick we wouldn't have the same issue we had last year. Councilmember Clendaniel asked if Rebecca knows

about this and Amy stated that in the past we have talked about an additional full time officer being covered under grant funding but that has not become available yet this year.

**Motion:** Councilmember Carroll made a motion to accept the June 2018 Police Report. Councilwoman Dolan-Beulah seconded the motion. The motion was passed unanimously.

**Budget Report:**

Amy presented the June 2018 Budget Report. There were no questions.

**Motion:** Councilmember Clendaniel made a motion to accept the June 2018 Budget Report. Councilmember Dolan - Beulah seconded the motion. The motion was passed unanimously.

Vice-Mayor Yapsuga stated that he will be at the Planning and Zoning Meetings for the Comprehensive Plan Review and he will report to Council at the meetings regarding the information discussed.

**MOTION:** Councilman Carroll made the motion to appoint Joe Yapsuga as the liaison during the review of the Comprehensive Plan. Councilmember Clendaniel seconded the motion.

**Summer Bash Update:**

Amy and Vice-Mayor Yapsuga gave a brief update to Council about the Summer Bash event and Joe discussed the businesses that he contacted for donations. Levi stated that we should contact Discover Bank in Greenwood; they are very generous with donations. Councilman Carroll stated that he asked Rebecca to make a donation to the Event instead of buying flowers for his brothers passing.

**The meeting was adjourned at 7:18.**
