

**Town of Felton
Town Council Meeting
January 11, 2021
6:30 pm**

Mayor Clendaniel called the Town Council Meeting of Felton to order at 6:30 pm on Monday, January 11, 2021. Present at the meeting were:

Council Members: Mayor Joanne Clendaniel, Vice-Mayor Joe Yapsuga Diana Dolan-Beulah, Bill Brittingham, and Anthony Carroll (via virtual).

Staff: Chief Levi Brown (via virtual), Town Manager, Amy Thomas and Town Clerk, Tracey Thompson.

Citizens Concerns:

There were no citizens concerns at this time.

Police Report:

Chief Brown presented the December 2020 Police report. There were no questions or comments.

Motion: Councilmember Dolan- Beulah made a motion to approve the December 2020 Police Report. Vice-Mayor Yapsuga seconded the motion. The motion was passed unanimously.

Budget Report:

Amy presented the December 2020 Budget Report. There were no questions or comments.

Motion: Vice- Mayor Yapsuga made a motion to accept the December 2020 Budget Report. Councilmember Dolan- Beulah seconded the motion. The motion was passed unanimously.

Public Works Report:

Amy presented the December Public Works Report. Vice-Mayor Yapsuga asked if we budgeted for salt for the roads for the upcoming winter months. Amy stated we budgeted \$500 for snow and ice removal.

Minutes:

Mayor Clendaniel presented the December 14, 2020 Town Council Meeting Minutes and January 6,2021 Planning and Zoning Meeting Minutes. There were no questions or comments.

Motion: Vice- Mayor Yapsuga made a motion to accept the Town Council Meeting Minutes and the Planning and Zoning Meeting Minutes. Councilmember Dolan- Beulah seconded the motion. The motion was passed unanimously.

Trash Rate Review:

Amy presented the new contract with GFL/ Waste Industries Trash Company. The contract states no price increase till 2022, and then at that time it will go up 3% each year for the next 4 years. This will bring our trash rate by the year 2025 to \$61.38. Councilmember's all agreed that in order to make a decision that they would like to see multiple bids to make sure we are providing the best service to the Town. Amy stated that the contract is due in March and that she will reach out to other trash companies to see how comparable they are to GFL.

Motion: Vice- Mayor Yapasuga made a motion to table the contract till next Council Meeting to look over other bids. Councilmember Dolan- Beulah seconded the motion. The motion was passed unanimously.

The meeting was adjourned at 7:17 pm for Executive Session.
