

**Town of Felton
Town Council Meeting
June 14, 2021
6:30 pm**

Mayor Clendaniel called the Town Council Meeting of Felton to order at 6:30 pm on Monday, June 15, 2021. Present at the meeting were:

Council Members: Mayor Joanne Clendaniel, Vice-Mayor Joe Yapsuga, Anthony Carroll, Diana Dolan-Beulah and Bill Brittingham.

Staff: Chief Brown, Town Manager, Amy Thomas and Town Clerk, Tracey Thompson.

Public: Patty Eccles (Resident), Mary Voshell (Lake Forest Community Foundation).

Citizens Concerns:

There were no citizens concerns at this time.

Police Report:

Chief Brown presented the May 2021 police report. He also stated that his date for his knee surgery will be October 4, 2021 and he intends to be out on sick, then take his vacation time and tentatively retire on January 1, 2022. He will be meeting with Amy to go over his sick and vacation time and after that he will have a more definite retirement date.

Motion: Vice Mayor Yapsuga made a motion to accept the May 2021 Police Report. Councilmember Carroll seconded the motion. The motion was passed unanimously.

Felton Fire Company Report:

Councilmember Brittingham presented the Felton Fire Company May Report. In the Month of May they had 35 Fire Alarm calls and 149 Ambulance calls. There were no questions or concerns on the May Felton Fire Company Report.

Town Council Meeting Minutes:

Motion: Councilmember Dolan-Beulah made a motion to accept the Town Council Meeting Minutes. Councilmember Carroll seconded the motion. The motion was passed unanimously.

Request for Gobble Wobble 5K Donation:

Mary Voshell who is a board member for the Lake Forest Community Education Foundation, thanked the Town of Felton for being a sponsor in previous years and allowing them in previous years to use the Town streets for the race. Mary Voshell asked for Council's permission to have the Gobble Wobble 5K Race in the Town of Felton with Police assistance on directing the traffic. Ms. Voshell stated that Gobble Wobble is to take place on Sunday November 21, 2021 9am to noon. Ms. Voshell presented a map of the race route (see attached). Council agreed to hold the Gobble Wobble event in Town this year. Ms. Voshell explained that the funds raised at the race will be given out in the form of grants to teachers in the district. Ms. Voshell asked if the Town was willing to be a sponsor again this year and gave the Council documents to see the levels of sponsorship (see attached).

Motion: Vice- Mayor Yapsuga made a motion to donate \$500 to the Gobble Wobble 5K. Councilmember Carroll seconded the motion. The motion was passed unanimously.

Resolution 21-R-03 Updating Comprehensive Plan Map to Change Zoning of 422 S Erin Avenue from Commercial to Residential:

Amy stated this resolution changes 422 S Erin Avenue to Residential on the Zoning Maps.

Motion: Councilmember Dolan- Beulah made a motion to accept the Resolution 21-R-03 Updating Comprehensive Plan Map to Change Zoning of 422 S Erin Avenue from Commercial to Residential. Vice Mayor Yapsuga seconded the motion. Roll Call: Mayor Clendaniel-yes, Councilmember Brittingham- yes, Councilmember Dolan-Beulah- yes, Councilmember Carroll- yes, Vice Mayor Yapsuga- yes.

The meeting was adjourned at 7:50 for Executive Session.
