## Town of Felton Town Council Meeting April 10, 2023 6:30 pm

Mayor Clendaniel called the Town Council Meeting of Felton to order at 6:30 pm on Monday, April 10, 2023. Present at the meeting were:

## <u>Vote on Change of Zoning Request - Turkey Point Road (Tax Map #SM 07-129.00-01-04.00/000)</u>

Mayor Clendaniel stated this vote is to start the PLUS Process with the State for the amendment to the Town's Comprehensive Plan. There was discussion on the rezoning.

### **ICS Sweep Accounts - Shore United Bank:**

Amy stated that she has spoken to other Municipalities that are participating in this program and received positive feedback.

**Motion:** Councilmember Carroll made a motion to participate in the Insured Cash Sweep Accounts with Shore United Bank. Vice Mayor Kelley seconded the motion. The motion was passed unanimously. #### FY24 Draft Budget:

Amy presented the FY24 Draft Budget and stated the following changes to the budget:

- Administration Budget Increased the Computer line; received notification from Response Computers that our server will expire October, 2024 and a server upgrade will cost \$8,046.
- General Budget Increased Auditor Line \$5,000 and decreased Council Pay since we do not pay a Councilmember anymore when they perform the monthly in-house audit.
- Police Budget Decreased Fines line to \$180,000 and decreased the Overtime Expense line another \$10,000 this year.
- Public Works Budget Decreased Chemicals line since we purchased Macrolyte last year.
- Health Insurance increased this year.
- Used the same calculation to predict the carryover number and due to the increase of taxes the last few years it has increased from last year.

There was discussion about Councilmembers getting paid for more than one meeting a night. It was decided that Amy will check the charter and also see if other Town's get paid for more than one meeting a night.

**Motion:** Vice-Mayor Kelley made a motion to give employees a 3% raise and accept the FY24 draft budget. Councilmember Carroll seconded the motion. The motion was passed unanimously. Roll Call: Mayor Clendaniel-yes, Vice Mayor Kelley- yes, Councilmember Carroll- yes, Councilmember Dolan-Beulah- yes, Councilmember Brittingham- yes.

The meeting was adjourned at 8:00pm for Executive Session.

The Regular Meeting reconvened at 8:32pm.
