Amy introduced Mr. Bradley as the developer of Turkey Point property. Mr. Bradley stated they are rezoning to R3 because it allows them more options to develop on the property. Two options being single family homes and town homes. Mr. Miller resident of Peach Basket Road asked Mr. Bradley questions about trees and if there would be some type of barrier between the properties. There was some discussion on town homes.

Amy stated this is a portion that Wawa needs off of Sanford Street for their entrance. There were no questions or concerns.

Motion: Vice-Mayor Kelley made a motion to accept the annexation request and allow them to move forward with the annexation process. Councilmember Carroll seconded the motion.
