Town of Felton Town Council Meeting February 12, 2024 6:15 pm

Mayor Clendaniel called the Town Council Meeting of Felton to order at 6:30 pm on Monday, February 12, 2024. Present at the meeting were:

Public Comments:

Debbie from D&D Deli is concerned about issues she is having with her neighbor next to the Deli. She stated that her neighbor has verbally assaulted her costumers due to an ongoing parking issue during business hours. She is more worried that the neighbor is going to get into a confrontation with the wrong person and someone is going to get hurt. Mr. Kemp a patron to the Deli spoke about a situation that happened recently involving himself and the neighbor. Valerie an employee of Deb's discussed an incident where she was verbally assaulted by the neighbor because she parked on the side of the road (not blocking the neighbor's driveway) and assumed since it was near the neighbor's home he was upset. Troy Dennis another neighbor of D&D Deli wanted to let Council know that he has no issue with people parking next to his home and that if there is ever an issue, he calls Deb and she gets it taken care of. There was discussion about parking in town and public streets.
