Town of Felton Town Council Meeting May 12, 2025 6:30 pm

Mayor Kelley called the Town Council Meeting of Felton to order at 6:32 pm on Monday, May 12, 2025. Present at the meeting were:

<u>Council Members</u>: Mayor David Kelley, Vice-Mayor Joanne Clendaniel, Marquise Broom, Diana Dolan-Beulah, and Bill Brittingham.

Staff: Chief Guild, Town Manager, Amy Thomas and Town Clerk, Tracey Thompson.

Public Comments:

- Councilmember Broom announced the VFW will be hosting the Memorial Day Ceremony Service on May 26th at 10am at Odd Fellows Park. They will also be placing flags on veteran grave stones at nearby cemeteries on May 24th at 9am.
- Resident Dick Jones had a concern about a ticket he received while riding with an expired temp tag last year, and questioned why the Public Works Kubota can drive on the streets.
